Who is the qualification for?

This qualification is designed for tenants in social housing who wish to increase their awareness of gas safety and fully understand their responsibilities and those of their landlord to comply with current legislation.

The course builds awareness in a non-technical way and so is also suitable for internal social housing staff, in particular those who do not visit properties or interact with tenants, but still need to understand organisational and tenant responsibilities regarding gas safety, such as Finance or HR departments. It is also a useful induction tool for new starters.

Increased safety and stronger landlord/tenant relationships

The course is designed to cover aspects of the safety of gas installations, carbon monoxide awareness and landlord and tenant responsibilities. It is particularly suitable for tenants who sit on resident panels, are tenant champions or who work closely with neighbourhood teams. It will build stronger relationships between the landlord and tenant and will contribute to continuous improvement in gas safety. The course is also relevant for Tenants Associations who wish to advocate for themselves. It will give them the knowledge to understand the responsibilities of the Landlord in providing timely repairs or servicing as required by the Gas Safety (Installation & Use) Regulations 1998.

The course can also be used to educate tenants who consistently refuse to allow access for annual service visits.

What experience is needed to take the course?

There are no formal entry requirements, but learners must have the minimum levels of literacy and numeracy to ensure completion of the learning outcomes and any assessment requirements.

This qualification is a half day training programme with an experienced Gas Expert from CORGI leading to a written examination consisting of multiple choice answers.

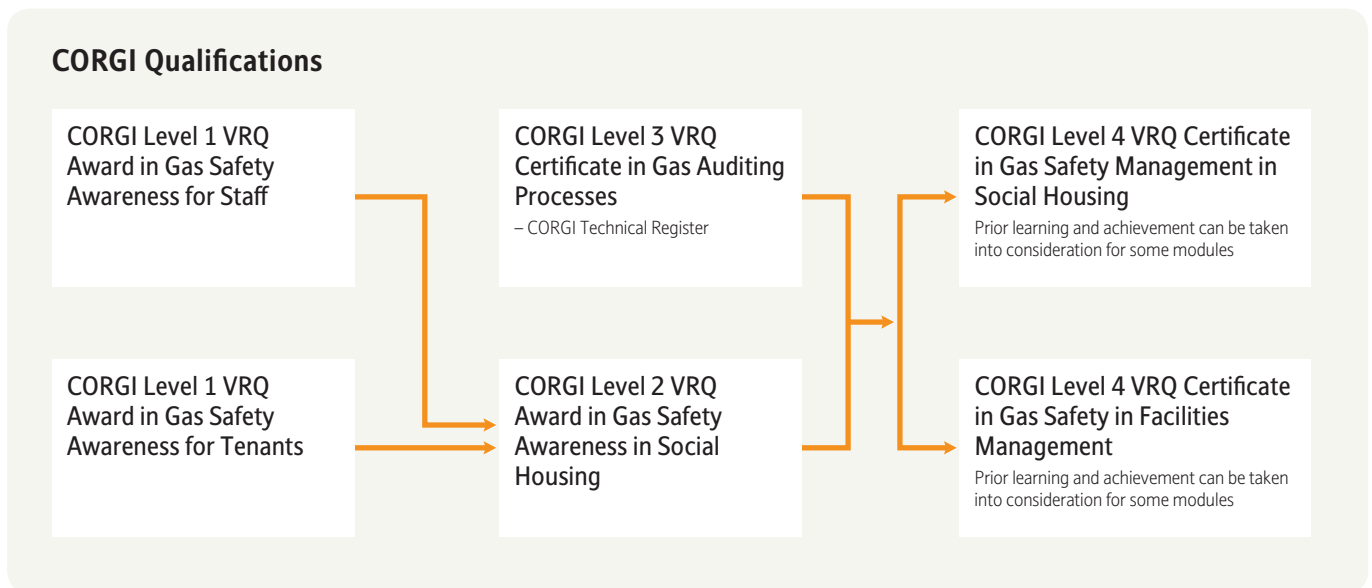
